Scotch Doubles Tournament: One partner must be a member of the San Jose Women's 500 Club. The other partner may be either male or female, but must hold a current USBC card.

1. This will be a scotch doubles handicap sanctioned tournament. The handicap will be 95% of 210. Teams will be assigned to divisions based on the team average.
2. Average:
 - a) the highest 2010-2011 book average (as of April 15, 2011)
 - b) current average of 21 or more games (with verification)
 - c) all others bowl scratch
 - d) bowlers are responsible for submitting correct average or will be disqualified. Corrections in average will be permitted up to the completion of the first game of the 3-game series.
 - e) USBC rules 319a2, 319c, 319d, and 319e will not apply.
3. Prize fund will be returned 100% at a ratio of 1 for each 5 entries.
4. **All bowlers must be checked in 15 minutes prior to check in time.**
5. Lanes will be assigned as entries are received. If you wish to bowl together, you must submit your entry forms together.
6. A prize list will be sent to each winner and a copy given to each lane representative to be posted in each establishment within 30 days of the tournament.
7. San Jose Women's 500 Club members must wear a 500 Club shirt, or a plain white or black long- or short-sleeved shirt with a collar, or pay a \$1.00 fine.
8. There will be a \$10.00 fee plus any bank charges for any returned check.
9. **Entry Fees are non refundable.** USBC Rule 134
